The IARC (International Agency for Research on Cancer) has listed titanium dioxide as "possibly carcinogenic to humans". However, Xerox has concluded that the presence of titanium dioxide in this mixture does not present a health hazard. The IARC classification is based on studies in rats using high concentrations of pure, unbound TiO₂ particles of respirable size. The Titanium Dioxide Industry REACH Consortium have concluded that these effects were species-specific, attributable to lung overload and not specific to TiO₂, i.e. similar effects would also be seen for other low solubility dusts.
